Eureka 54 Junior's Report Card Policy

The intent of the report card policy is to insure that Eureka Volunteer Fire & Ambulance Company will not be responsible for junior and senior high school students failing in their academic studies. This policy applies to all students in school. **NO EXCEPTIONS.**

1. It is the junior responsibility to submit their report card to the junior advisor within 48 hours after being issued.
2. If the advisor does not see a report card within 2 weeks, an immediate suspension will take place. (unless special situation warrant delay)
3. After submitting the report card to the junior advisor the following procedures will take place:
 - A: For each and any failing grades, an automatic 14 day suspension will take place.
 - B: Following the appropriate suspension the parents or guardian is to contact the advisor as to whether the grades have improved.
 - C: Upon improving grades the suspension may be revoked, however if the student is still failing the suspension will continue until acceptable grades are attained.
4. Any member that is in school must be off station grounds by 8:30 pm (20:30) on school nights, unless involved with training.
5. These rules are subject to change with the Eureka VFC approval.
